



# Report of the Treasurer

I am pleased to address you today and share my report for the fiscal year 2022-2023.

It is with a great deal of satisfaction that I present the Financial Statements for the year ended March 31, 2023, that was audited by MNP. The audit opinion is expressed in the Auditor's Report covering the financial statements. My personal thanks to the MNP Team for their ongoing support and expertise they have provided the organization.

#### Statement of Operations

The Statement provides a summary of the overall operating results for the LGCFHT. Funding for the LGCFHT is provided by the Ministry of Health and Long-Term Care. Under agreements with the Ministry, the LGCFHT operations are funded on a 'break even' basis. Any under expenditures for the year compared to contributions must be returned to the Ministry of Health. Any expenditure in excess of government contributions must be funded by other resources.

For the year ended March 31, 2023, contributions exceeded expenses by \$582,456 related to specific purpose funding, which has been set up as contributions repayable to the Ministry of Health in the statement of financial position. I continue to see a strong focus on providing quality patient care while keeping a close eye on expenses.

On behalf of the LGCFHT Executive Committee, I would like to take this opportunity to thank all staff and management for their dedication and efforts during a very challenging year given the staffing turnover and added time demands. ## **Programs**



#### **Diabetes Education Centre (DEC)**

Whether patients have pre-diabetes, type one, type two, or gestational diabetes, the diabetes team will collaborate, with the patient's health care provider, to ensure optimal health. This program is open to all members of the community. Both Registered Nurse and Dietitian work with the patient.



#### Social Worker & Psychiatrist

Providing individual, couple counselling, and supportive therapy for any identified mental health issues.



#### **Lumps & Bumps**

The LGCFHT's Lumps & Bumps clinic helps to prevent unnecessary wait times to plastic surgery and/or dermatologists.

### **Programs**



#### **Lung Health**

Or goal is to screen for chronic breathing conditions and improve health outcomes of adults, and children, living with asthma and COPD, by providing in-office spirometry testing, education, action planning and medication assessments/adjustments.



#### **Smoking Reduction Program (SRP)**

Smoking cessation/reduction services to help improve the patient's chances of quitting and to support patients through their quit journey.



#### **Clinical Pharmacist**

Supporting patients with an emphasis on optimizing medication management, focusing on completion of comprehensive medication reviews and identification of drug therapy problems.

#### **Prenatal**

Health promotion and prenatal care.



#### Well Baby

Well baby, well child development screening and immunizations.



#### **Cervical Screening**

Helping to ensure women are up-to-date with routine pap screening.

#### **NutriSTEP**

The LGCFHT's Dietitian can assess the eating habits of of children 18 months to 5 years of age - using NutriSTEP. NutriSTEP screening is a tool to identify nutritional problems. The Dietitian can then provide tips and ideas to help address any nutritional issues.
